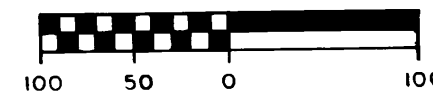

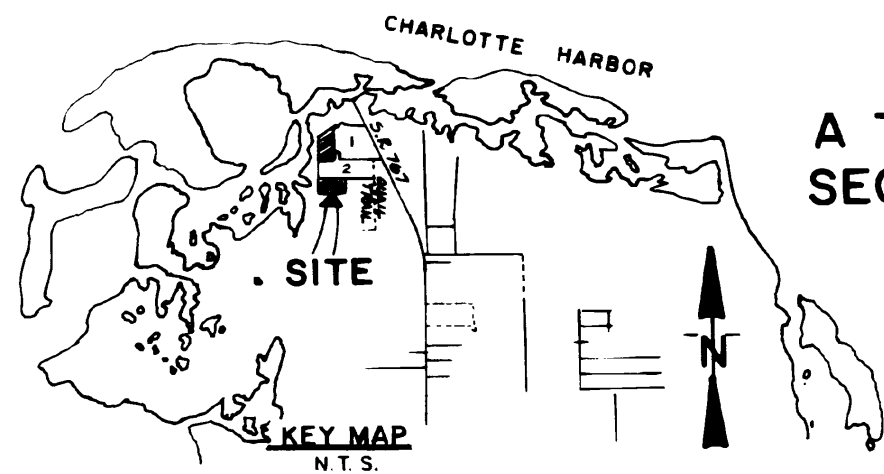
UNIT THREE CAPTAIN'S COVE A SUBDIVISION

DESCRIPTION OF PROPERTY

TWO TRACTS OR PARCELS OF LAND IN GOVERNMENT LOT 3 AND GOVERNMENT LOT 4, SECTION 30, TOWNSHIP 43 SOUTH, RANGE 22 EAST, LEE COUNTY, FLORIDA, WHICH ARE DESCRIBED AS FOLLOWS:

FROM THE SOUTHWEST CORNER OF SAID SECTION 30; THENCE N 0° 26' 20" W ALONG THE WEST LINE OF SAID SECTION FOR 370.0 FEET TO THE POINT OF BEGINNING OF TRACT 1; THENCE CONTINUE N 0° 26' 20" W ALONG SAID WEST LINE FOR 289.73 FEET; THENCE N 89° 33' 40" E ALONG THE SOUTH BOUNDARY OF CAPTAIN'S COVE UNIT II, A SUBDIVISION AS RECORDED IN PLAT BOOK 32 AT PAGE 35 OF THE LEE COUNTY, FLORIDA PUBLIC RECORDS FOR 679.32 FEET; THENCE S 0° 23' 53" E FOR 290.61 FEET; THENCE S 89° 33' 40" W ALONG THE NORTH LINE OF A 60.0 FOOT WIDE 130.0 FEET EACH SIDE OF CENTER LINE ROADWAY EASEMENT AS RECORDED IN O.R. BOOK 1126, PAGES 60 TO 61 FOR 679.12 FEET TO THE POINT OF BEGINNING.
